- Operate within shared values around community building



FY2024 Funded Projects

Aging-in-Place Grant

- Annual funding opportunity in statute
- \$300,000 available for Area Agencies on Aging and nonprofits through competitive process
- 20% of funds must be distributed to "Senior Villages"
- 50% Matching requirement
- Services may include In-home personal care services; Psychological, economic, or functional assistance; Awareness and access to resources; Support services and care coordination; Affordable transportation; Assistance with home modifications or repairs.
- 8 grantees supported in FY2024, including 4 Village models

Healthy Aging, Supportive Communities Grant

- Funding opportunity, released through 2 competitive opportunities:
 - 1). Technical assistance –organizations providing training and consultation to improve organization capacity around fiscal management, volunteer management, outreach and marketing, etc.
 - 2). Service providers-delivering community-based supportive services to older adults and their caregivers.

- Support for HB 1103: The Miriam Kelty Aging and Senior Social Connection Hub and Spoke Pilot Program.






FY2024 Funded Projects

- Washington Area Villages Exchange (WAVE)
 - Village association for Maryland, DC, and Virginia, dedicate to supporting village communities through education and resources.
 - Providing education, coaching, and consultation
 - Assessing current data collection practices across villages to identify challenges and improve efficiency
- Village capacity building internships
 - Two paid interns to enhance and expand the Village network
 - Research and analysis at the state level
 - Outreach and asset mapping in Allegany County and the Baltimore area to build awareness and potential application of the Village model locally
